

Paylogic Terms & Conditions Ticket Installment Plan

January 2019

Paylogic is the trademark for See Tickets B.V.

These terms and conditions apply to tickets and other related products sold via an installment plan as payment method.

By choosing installment plan as a payment method, you agree to a non-refundable purchase via two or more 'installments' which will be deducted from your credit card according to these terms and conditions. You will obtain the conditional right to receive a ticket or related product after your first installment, provided that you pay all subsequent installment in a timely manner. Once the last installment is received by Paylogic, you will obtain the ticket or related product via email or postal service.

IMPORTANT Paylogic acts solely as a technical service provider for (or 'agent' of) the organiser of this event. This agreement, to buy tickets or related product via installments, will be between you (as the buyer) and the event organiser (the seller). Please find the contact information of the organiser through the website of your purchase.

Article 1 - Definitions

Buyer	You, as the party that purchases a product via Installment Plan;
Event	Private event like, but not limited to, a musical, theatrical, dramatic or musical performances, a concert, show or a sports event;
Organiser	The party committed to, and responsible for, organizing the Event. Also to be qualified as the seller;
Paylogic	The legal entity Paylogic, statutorily seated in Groningen, The Netherlands at the address of Nieuwe Boteringestraat 28-30 (9712PM) and registered at the Chamber of Commerce of Groningen under registration number 01140404 (also referred to “we” or “us”);
Payment details	Contact and bank details of the Buyer which are required for the completion of a purchase transaction;
Refund	Reimbursement of the amount(s) paid, minus applicable costs and fees;
Installment Plan	The payment method by which you buy a product through one or more installments and according to these terms and conditions.

Article 2 - General Conditions of Paylogic

These Terms & conditions are subject to the General Terms and Conditions of Paylogic.

Article 3 - Installment Plan and payments

For selected Events, the Buyer (you) may choose to pay in installments (hereafter: ‘Installment Plan’). By agreeing to these terms and conditions, you unconditionally agree to pay the total purchase price as shown on the website of the Organiser, including the number of installments and the due date of each installment.

By choosing to use of the Installment Plan during the order process, you authorise Paylogic to charge the first installment amount to your credit card according to your Payment Details. All subsequent installments will then be deducted from the same credit card. The amounts per

installment, number of installments and installment periods may vary per Event and/or per Organiser and will be clearly provided to you during your purchase.

By paying the first installment, you obtain the **conditional** right to receive a ticket, under the condition that all subsequent installment will be timely paid to Paylogic. Paylogic will notify you in any case where the the installments are either fully paid and you will receive a ticket, or whenever you default on one or more installments, requesting you to fulfill your obligation of payment within a given period of time. Should you not pay in time, Paylogic holds the right to cancel your purchase on behalf of the Organiser without a Refund (see article 4).

Article 4 - Cancellation and Refund

By selecting Installment Plan as a payment method, you unconditionally agree to pay all the installment amounts according to the Installment Plan.

In case an installment is not (timely) received by Paylogic, for example because your account holds insufficient funds or your Payment Details are incorrect, Paylogic will notify you about the missing payments, after which said payments need to be transferred to Paylogic within 5 calendar days of the notification. By not (timely) paying the corresponding amount of each installment, you forfeit your right to receive a ticket or related product, at which time Paylogic is entitled to cancel your order. You will **not** receive a Refund for installments already paid. The amounts will be withheld by Paylogic/Organiser because of the processing and administration costs related to your purchase and the fact that the Organiser might not be able to re-sell the product, unless the Event is canceled during the first and last installment.

Article 5 - Applicable law and forum

Solely the Dutch law is applicable to these Terms & Conditions.

All disputes arising from these Terms will be in first instance for the purpose settled by a competent court in Amsterdam.
